DDRS- Mission

Recap- 2015:

- Victim prevention/abuse neglect: Goal to have Indiana be a 0 tolerance state
- Worked on collaboration team with NASDDs and DDRS to solidify vision of DDRS
- Closure of North Willow more than 120 people moved to the community
- Rate restoration of cuts in 2010 (2.5% in July 15, another 2.5% coming in July 16)
- No reduction in BMAN rates in a long time. No increase OR decrease being considered.
- VR- methodology change for reimbursement of services
- Now at seven CM providers
- Provider relations- not approving new BMAN company's. State is happy with capacity and quality controls in place. Continue meeting need as we grow.
- Two FSSA audit processes this year Wellness and BMAN
- 460 does not tell you what reimbursable activities are. Go to the Waiver manual to see what reimbursable activities are. (http://www.in.gov/fssa/ddrs/4312.htm)
- Daily rate returned for individual's with shared services in RHS. Algo 3, 4, 5
- Behavior reporting has to be quarterly, not monthly.
- Waiver Transformation
 - Intense behavior residential services (IRS-B) Designed for those people, if their team deems it necessary, will receive this service. Wrap around. Provider will provide

- residential, nursing and behavioral services. Will work in collaboration with a Crisis Team from the state. Provide feedback on this.
- Another new service will be IRS-M similar model, just for people with outstanding medical challenges.
- Keep up with recommended changes with the CIH Waiver as well as the upcoming amendment: http://www.in.gov/fssa/ddrs/4988.htm
- Federal law—-sometime down the road. Medicaid services for minors could impact how Behavioral Services on the waiver. To learn more: https://www.medicaid.gov/medicaid-chip-program-information/by-topics/benefits/downloads/epsdt_coverage_guide.pdf
- Liaison job. DD advisory committee (advise DDRS on policies)
- 33,000 on waiting list in 2006. Receiving services less than 14,000. 20,184 on waiver services in 2015, 3253 in group homes. ICF's seen as a more restrictive environment than community living. Reduced ICF beds by 13% this past year. #that get behavior services 8,749.

Recommendations for 2016:

- Risks vs. benefits. If risks outweigh, not a benefit to do.
- Do not cut and paste. Write plans for an individual.
- Calling 911 is not an intervention that should be in the BSP's.
- Be a good steward of resources
- Reporting. Even if someone on your team is violating rights or doing something that is not in the individual's best interest. Your responsibility to report that.
- Availability of yourself as a BC and recruiting others to be BC's.
- Nationally, most states are working toward managed care, we are a fee for service state. New changes, looking at differently but not a major overhaul.
- The system as we do it today is not fiscally sustainable.
- Accountability. Client rights, system consistency,
- Get more done with collaboration than competition.
